In both of the additional videos, both incidents were captured during daylight hours. Video footage showed an unknown white male exiting the Infiniti sedan and removing numerous items from the affixed boxes of the same work truck listed above. The first video on today's date captured the suspect committing the offense at approximately 1734 hours. The second video provided captured a separate (2nd incident on today's date) occurring at approximately 1819 hours. Both videos captured an unknown white male removing various tools from within the affixed boxes of the work truck. The second video capture a license plate that was displayed on the rear of the gray Infiniti sedan, SC license plate VEE817.

This license plate was ran through SCDMV online files and confirmed registered to a Wiliam D. Hester subject out of Newberry, SC. Moritz and Nero both stated that it would take some time to compile a full list of the numerous tools that had been stolen. My city email was provided along with a Cayce PD business card. A victim's rights form was issued to both Moritz and Nero prior to my departure. Moritz stated that the compiled spread sheet would be emailed to my city email on -7/11/2022. Nero stated that the total value of said tools that were stolen would range from \$2,000 to \$10,000 dollars.

Prior to my departure, Nero was able to provide a small list of tools that were definitively stolen thus far. This list includes as follows;

- 1 3 sets of Cornwell 3/8" drive socket sets ranging from 1 ¼ " to 2 3/8 " with Power Pro stamped on the wrenches in total valued at \$700 dollars to \$800 dollars
- 2 1 set of Matco ratchet wrenches standard silver color ranging from 1/4 to 3/4 valued at \$300 dollars
- 3 1 set of silver colored gear ratchet wrenches 8mm to 17mm valued at \$260 dollars
- 4 1 1/4 inch drive Matco electric ratchet burgundy in color valued at \$330 dollars (charger was left behind at the scene)
- 5- ½ drive Pittsburgh socket set (red case black sockets) valued at \$60 dollars
- 6 1 Craftsman multimeter voltage reader (red/black) valued at \$120 dollars
- 7 1 Milwaukee ½ inch drive impact drill (primarily red) valued at \$700 dollars

Total value so far = \$2,570 dollars

Both victims wish to pursue criminal charges.
