Green provided me with a copy of Bowie's SC DL (SC-007447129) (W/M, 5'8", 190lbs, BRO eyes) and a phone number that Bowie used to check in with 803-791-5850.

I then met with Jose Coltes (maintenance) in room 240. Coltes provided me with the following information for the missing property

LG 30" TV - S/N 602MX8PQ8901 (Coltes was unable to provide a value of the TV)  
Magic Chef (mini-fridge black in color) - Unknown S/N | Unknown Value.

Coltes provided me access to another adjacent room which had the same TV and refrigerator to obtain photographs of the items for reference. These photos were later saved to the evidence server.

DETAILED STATEMENT OF INVESTIGATION: An investigation of this alleged incident was conducted and is concluded as of this date. The circumstances of the closure/suspension are listed below:

Definitions:

ADMINISTRATIVELY CLOSED - typically means that all reasonable leads are exhausted, or there was a lack of leads or evidence to justify further investigative activity. This case status can be changed if new leads or evidence is discovered in the future.

CLOSED BY ARREST - The investigation has resulted in at least one suspect being charged. For this definition, an arrest could be a custodial arrest, summons/citation issued, juvenile released to parents, juvenile family court referral, juvenile detained at SCDJJ.

EXCEPTIONAL CLEARANCE - this is used in cases where a suspect has been identified, located, and probable cause exists for a charge to be made, but a reason to not charge exists, such as the suspect is outside of extradition limits, is already sentenced to substantial prison time for other crime(s), the suspect dies prior to arrest, prosecution is declined by the prosecutor, or the victim refuses to cooperate.

UNFOUNDED - the investigation shows that the alleged criminal act did not occur, or if it did occur, it occurred outside of the jurisdiction of this agency. In the latter circumstance, the case is forwarded to the appropriate jurisdiction to handle.

GRAND LARCENY - \$2,000 TO \$10,000 (TFMV)

On 07/10/2022 at 2223 hours I MPSTO Branham responded to 2326 Charleston Hwy (Business / Fleet Truck Repair) located within the city limits of Cayce county of Lexington, SC in reference to a theft from a motor vehicle. Cayce Dispatch advised that the incident occurred approximately 1 hour prior to the call for service.

Upon my arrival I made contact with the complainant Dwayne Moritz who was identified by his SCDL. Also contact was made with a second complainant, Quinton A. Nero, also identified by his SCDL. Moritz and Nero stated that multiple tools were stolen from the metal compartments of work bed affixed to a 2015 Ford F250 bearing SC license plate P841339 (VIN: 1FD7X2A61FEC84450 / registered to Fleet Truck Repair). Moritz stated that the work body had been affixed to the truck since the date of purchase.

Moritz stated that video footage had been captured the incident. Moritz stated that the suspect vehicle involved with case number 22-08005 was the same vehicle involved in today's incident. Video footage captured was appeared to be a dark gray/blue Infinity sedan departing the scene. Also in the same video clip, the work truck's tool boxes were observed to have been left opened as the vehicle leaves the parking lot with its headlights deactivated. While reviewing the video footage, additional video footage was discovered. Additional footage from today's date involving the same vehicle captured, adding two additional incidents to today's date.

In both of the additional videos, both incidents were captured during daylight hours. Video footage showed an unknown white male exiting the Infiniti sedan and removing numerous items from the affixed boxes of the same work truck listed above. The first video on today's date captured the suspect committing the offense at approximately 1734 hours. The second video provided captured a separate (2nd incident on today's date) occurring at approximately 1819 hours. Both videos captured an unknown white male removing various tools from within the affixed boxes of the work truck. The second video capture a license plate that was displayed on the rear of the gray Infiniti sedan, SC license plate VEE817.

This license plate was ran through SCDMV online files and confirmed registered to a William D. Hester subject out of Newberry, SC. Moritz and Nero both stated that it would take some time to compile a full list of the numerous tools that had been stolen. My city email was provided along with a Cayce PD business card. A victim's rights form was issued to both Moritz and Nero prior to my departure. Moritz stated that the compiled spread sheet would be emailed to my city email on -7/11/2022. Nero stated that the total value of said tools that were stolen would range from \$2,000 to \$10,000 dollars.

Prior to my departure, Nero was able to provide a small list of tools that were definitively stolen thus far. This list includes as follows;
